IT organization

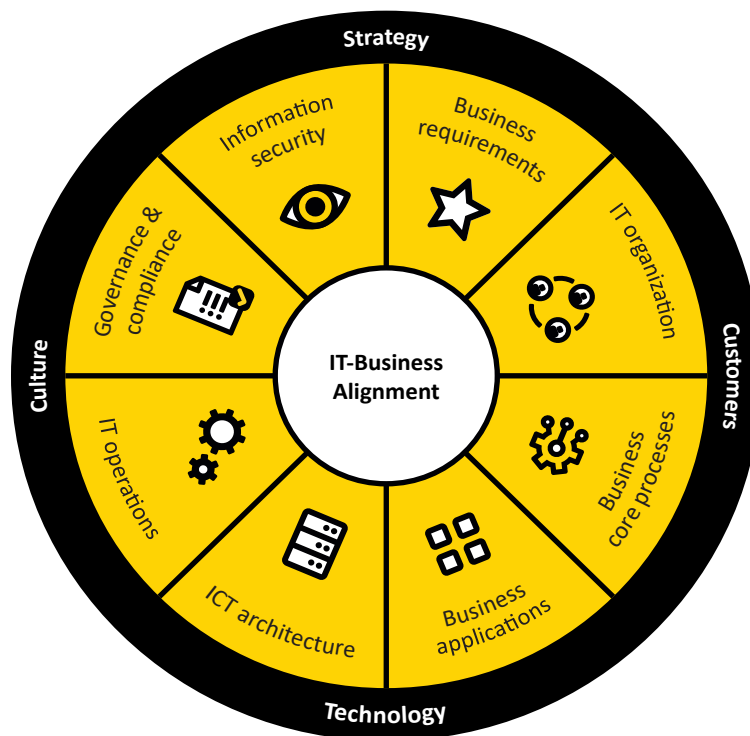
How is the IT structure organized? Are responsibilities and competencies defined? Is there a substitution regulation? Is a sourcing model defined...
